OVERVIEW

Purpose of Report

To present Council with an application to amend an existing liquor licence at 940 Old Victoria Road.

Recommendation

That Council recommend the Liquor Cannabis and Regulation Branch approve the application for 940 Old Victoria Road (Wolf Brewing Company) to amend their liquor licence to permit the hours of operation to be 9:00 a.m. to 11:00 p.m. seven days per week.

BACKGROUND

A notice of application was received from Wolf Brewing Company, requesting a local government resolution in support of their licence amendment application to the Provincial Liquor and Cannabis Regulation Branch (LCRB), to extend their hours of service. An information report was presented to Council on 2020-MAR-16, and public comment sheets were mailed to the neighbourhood on 2020-MAR-18. Council previously supported the manufacturer's lounge liquor licence in April 2018. The applicant states the extended hours will attract customers and enable them to market the brewery as a venue for social events.

DISCUSSION

When considering liquor licence amendment applications, the LCRB requests the City take into account the:

- location of the establishment,
- public consultation methods,
- the person capacity and hours of liquor service,
- impact of noise on the immediate vicinity, and
- impact on the community if the application is approved.

Location of the Establishment

The subject property is located within an industrial park in Nanaimo's South End Neighbourhood. The Official Community Plan designates the property and surrounding area as 'Light Industrial'. The property is zoned Light Industrial (I2). The existing uses in the immediate vicinity are primarily industrial, with some residential surrounding the industrial park. This



includes single family dwellings along Old Victoria Road and a multi-family development, Newport Vista Village.

Public Consultation

The following summarizes the opportunities for information sharing and public consultation for the proposed changes to the liquor licence at 940 Old Victoria Road:

- An information report was on the Council agenda for the 2020-MAR-16 meeting.
- The liquor licence amendment application was referred to the South End Community Association. The neighbourhood group indicated the application was presented at an online board meeting and again at their online general meeting, at which group members expressed their support for the application and had no concerns.
- A comment sheet with information about the proposed changes to the liquor licence was mailed to the property owners and tenants within 100m of the subject property.
- A total of two completed comment sheets were received by the City (See Attachment C). Both comment sheets indicate support for the proposed changes to the liquor licence.
- The liquor licence amendment application was referred to the RCMP and the City's internal departments for review and comments. Their comments are summarized in the sections below.

Person Capacity and Hours of Liquor Service

The Wolf Brewing Company building has a maximum capacity of 60 persons. The business includes an interior area for beer manufacturing, an onsite store, and a lounge area for patrons. The lounge includes an interior area (393.74m²) and an outdoor patio (7.11m²).

The applicant is proposing to extend the hours of service such that the business has the potential to be open from 9:00 a.m. to 11:00 p.m. seven days per week.

Impact of Noise on the Community in the Immediate Vicinity of the Establishment

The Bylaw Services and Business Licensing Sections have not received any nuisance complaints regarding Wolf Brewing Company. The subject property is located within an existing industrial park, thus Staff do not anticipate the change in hours will have a negative noise impact in the immediate vicinity.

Impact on the Community if the Application is Approved

This application was referred to the RCMP, Building, and Fire departments and there are no concerns regarding the application. Staff do not anticipate the proposed liquor licence amendment application will result in any negative impact to the community.



SUMMARY POINTS

- A notice of application was received from Wolf Brewing Company (940 Old Victoria Road) requesting a local government resolution in support of their application to the LCRB to amend their existing liquor licence to extend their hours of service.
- The City completed a referral process and public consultation to obtain feedback regarding the proposed amendments to the liquor licence.
- No concerns were raised regarding the proposal to change the hours of service to 9:00 a.m. to 11:00 p.m. seven days per week.





Re: Application for Change to Hours of Liquor Service

The purpose of this application is to request a change to Wolf Brewing Company Ltd's hours of liquor service. Please find the following information to support our application:

Nature of the Business

Wolf Brewing Company Ltd (Wolf) is a craft brewery located at 940 Old Victoria Road proudly operating in the City of Nanaimo under Business License #5027608 and under BC LCRB Brewing Licence #300113. Wolf manufactures a wide range of craft beers and offers those products for consumption and sale in our onsite lounge in accordance with our approved Lounge and On-Site Store endorsements. We currently employ 10 personnel.

Requested Change and Rationale for Proposed Amendment

We are requesting a change from our current hours of:

Mon-Thurs:	12pm – 6pm
Fri-Sat:	12pm – 8pm
Sun:	12pm – 5pm

To the hours of: Mon-Sun: 9am – 11pm



As business owners, we aim to deliver quality products and service resulting in a strong customer base, gainful employment to local residents, support to local business partners and, ultimately, delivering a sustainable, profitable business. However, we are concerned that our business and the ability to deliver on these objectives is at risk with our current, limited hours of liquor service operation.

Some of our concerns (which are consistent with feedback from many of our customers) stem from:

- With a closing time of 6pm during the work week, it is difficult for many customers that finish their work day at +/- 5pm to choose Wolf;
- Closing times of 8pm on Fri/Sat and 5pm on Sun put Wolf as an inferior choice for social gatherings on weekends;
- Our ability to host evening social and/or community activity events is significantly limited with current closing times;
- Common feedback indicates that our limited hours act as a deterrent for the acquisition of new customers;
- Despite brewing and management staff being on-site by 8:30am each day, customers are not able to fill their 'growlers' or purchase packaged products from our on-site store until noon.

The combination of these factors restrict our ability to achieve and maintain a sustainable, profitable business.

While we may not consistently maintain open hours of service between 9arn – 11pm seven days per week, our intention is to maintain flexibility to operate our business within the City of Nanaimo's Bylaw No. 4750 – (*A Bylaw to Regulate or Prohibit the Making or Causing of Noises or Sound in the Municipality*) with the following additional supporting rationale:

- The request for earlier hours is primarily aimed to enable increased access to our on-site store for purchasing 'growler' fills and packaged product;
- The request for later hours is aimed to provide increased access for our current patrons to enjoy Wolf's onsite lounge, to attract new customers, to become a viable venue for community/social events, and to increase sales of both our onsite lounge and store.

The combination of these factors will increase Wolf's ability to maintain a profitable business while operating within service hours that are respectful of both the City of Nanaimo's ByLaw No. 4750 and of neighbouring residents and businesses.

Community Impact Statement

As a local business, we are respectful and sensitive to the impacts that our operation has on the local community. We believe that the change of liquor service hours will have little to no impact

on the local community. We offer the following considerations and measures to support our belief:

- The proposed hours of 9am 11pm are aligned with the City of Nanaimo's noise-related ByLaw No. 4750 to which Wolf will strictly adhere to;
- To our knowledge as the owners of Wolf since February 1, 2019, Wolf has not had a single complaint filed against it – this includes from neighbouring business owner or residents. We care about our reputation and will continue to take measures to protect it. Should a complaint be filed, stakeholders can be assured that it will be treated seriously and swiftly;
- Located in a predominantly industrial area, the exit from Wolf is onto Old Victoria Road which is largely an industrial road out of immediate site from any residences;
- Consistent with regulatory requirements, all Wolf employees have their Serving It Right training and are committed to their obligations therein;
- With limited nearby venues of its kind, many of Wolf's customers have identified themselves as local residents and local business owners/employees expressing their excitement at the potential of Wolf's extended hours.

Thank you in advance for your consideration of this application. Wolf firmly believes that approval of this request will benefit Wolf, our customers, our employees, and the local community. We look forward to continuing to be a contributing member to the Nanaimo business community.
