THEREFORE BE IT RESOLVED the Municipal Council of the City of Nanaimo, in open meeting assembled, ENACTS AS FOLLOWS:


- 1. This Bylaw may be cited as the "ZONING AMENDMENT BYLAW 2012 NO. 4500.022".
