BYLAW NO. 7104

A BYLAW TO PROVIDE FOR HIGHWAY CLOSURE AND DEDICATION REMOVAL OF A PORTION OF THE UNNAMED LANE SOUTH OF MEDEA WAY AND WEST OF HECATE STREET

WHEREAS Council has deemed it expedient to stop up and close to traffic and remove highway dedication to a portion of the unnamed lane South of Medea Way and West of Hecate Street for the purpose of disposing of the land to the adjacent landowner for consolidation with the adjacent landowner's lands; and

WHEREAS all lands and premises immediately adjoining, and in the vicinity of the portion of highway that is stopped up and closed and highway dedication removed, are adequately serviced by well-established highways giving convenient access to all such premises; and

WHEREAS public notice pursuant to Section 94 of the *Community Charter* has been published in a newspaper circulating in the City of Nanaimo;

THEREFORE the Council of the City of Nanaimo, in open meeting assembled, hereby ENACTS AS FOLLOWS:

- 1. This Bylaw may be cited for all purposes as "HIGHWAY CLOSURE AND DEDICATION REMOVAL (PORTION OF THE UNNAMED LANE SOUTH OF MEDEA WAY AND WEST OF HECATE STREET) BYLAW 2010 NO. 7104".
- 2. A portion of the unnamed lane South of Medea Way and West of Hecate Street in Block O, Plan 584, Section 1, Nanaimo District shown as Closed Road comprising 588.1 square metres on a plan to accompany City of Nanaimo Bylaw No. 7104, prepared by Andre McNicoll, B.C. Land Surveyor, a print of which is attached as Schedule A to " HIGHWAY CLOSURE AND DEDICATION REMOVAL (PORTION OF THE UNNAMED LANE SOUTH OF MEDEA WAY AND WEST OF HECATE STREET) BYLAW 2010 NO. 7104", is hereby closed to all traffic.
- 3. The highway dedication of that portion the unnamed lane South of Medea Way and West of Hecate Street referred to in section 2 is hereby removed.

4. His Worship the Mayor and the Manager of Legislative Services are hereby authorized to execute all the necessary documents as may be required for the due completion of the aforesaid highway closure and dedication removal.


