RE: LIQUOR LICENCE APPLICATION NO. LA000107 - APPLICATION FOR AN ENTERTAINMENT ENDORSEMENT FOR A FOOD PRIMARY LIQUOR LICENCE - NEW YORK STYLE PIZZA AND PASTA - 299 WALLACE STREET

## STAFF RECOMMENDATION:

That Council recommend the Liquor Control and Licensing Branch (LCLB) approve an application to include patron participation entertainment as part of New York Style Pizza and Pasta's existing food primary liquor licence.

### PURPOSE:

The purpose of this report is to request Council comment regarding. New York Style Pizza and Pasta's (299 Wallace Street) application to permit patron participation entertainment within the existing food primary licensed restaurant. As Council is aware, a municipal resolution is required before the province will consider the application further.

## BACKGROUND:

The City has received correspondence from Ms. Vivian Maltesen (New York Pizza) requesting a local government resolution in support of her application to the provincial LCLB to allow for patron participation (karaoke) within her existing food primary licensed establishment.

The subject property is located within the City's downtown core and is included within the Downtown-Fitzwilliam (DT2) zone. The DT2 zone permits a neighbourhood pub where live entertainment, dancing and karaoke are allowed.

In June 2002, the City of Nanaimo retained Neilson-Welch Consulting Inc., to prepare a Liquor Control Strategy, which Council subsequently adopted. In terms of food primary establishments, the Liquor Control Strategy recommends that Council support restaurants that wish to include patron participation, but only in cases where the restaurant provides, in writing, an outline of the types of entertainment proposed, and the assurance that food service will remain as the primary function. The restaurant wishes to allow patrons to partake in karaoke in an environment that permits children and families. The applicant has provided a letter of assurance (Attachment B).

### DISCUSSION:

As part of the food primary amendment review process, the LCLB asks the local government to comment on the following:

• The potential for noise if the application is approved: The subject property is located on the corner of Fitzwilliam and Wallace Streets, both of which are major collector roads within the City's downtown core, bordering the Old City Neighbourhood Plan area. The surrounding land use within the area is predominantly commercial. No residential buildings are within 100m of the subject property.

The restaurant's hours of operation are 11am to 9pm Sunday to Thursday and 11am to 10pm on Friday and Saturday. The applicant is proposing to offer a family karaoke event from 6pm to 9pm.

Given the limited hours of the event and the absence of neighbouring residential buildings in the area, Staff believes the application will not result in any increased noise and disturbance to neighbouring residents.

• The impact on the community if the application is approved: The subject property is included within the Downtown Urban Node within the City's Official Community Plan (OCP). The Downtown Urban Node supports "the continued development of unique and interesting commercial and service uses" and a strong arts and culture theme. While karaoke is commonly offered in other Nanaimo area pubs, the applicant is proposing to host a unique activity in which children will be able to participate in karaoke with their families.

A referral was sent to the Nanaimo Old City Association and the Downtown Business Improvement Association (DNBIA).

The RCMP has no concerns with the proposed entertainment endorsement for the restaurant. A copy of the RCMP referral response is included (Attachment C).

- Where the amendment may result in the establishment being operated in a manner contrary to its primary purpose: The restaurant will provide a full menu and has provided written assurance that the primary function will be that of a restaurant (Attachment B). All restaurant guests will be seated at tables but will have the opportunity to get up and sing during the three hour karaoke event.
- The views of residents / neighboring businesses: A public notice and comment sheet was mailed and hand delivered to the owners, residents and business owners of buildings and properties within 100m of the subject property. A total of 70 comment sheets were delivered. Twelve responses have been received; 12 are in support of the application while none are opposed. A summary of the responses received is attached (Attachment D).

#### Opt Out of Application Process

With respect to all food and liquor primary licence applications, it is worth noting that Council has the option to provide no comment. If Council chooses to opt out of the application process, Staff will inform the LCLB of Council's decision and no further action will be taken by Staff regarding the application.

If a local government chooses to opt out, the LCLB will start their own review process, which could considerably delay the application process. As such, Staff recommends that Council does not opt out of the decision making process regarding this application.

## **Next Steps**

Once Council has made a recommendation regarding the application to endorse patron participation entertainment, Staff will forward the recommendations to the LCLB. The final decision regarding this food primary licence amendment application will be made by the LCLB.


