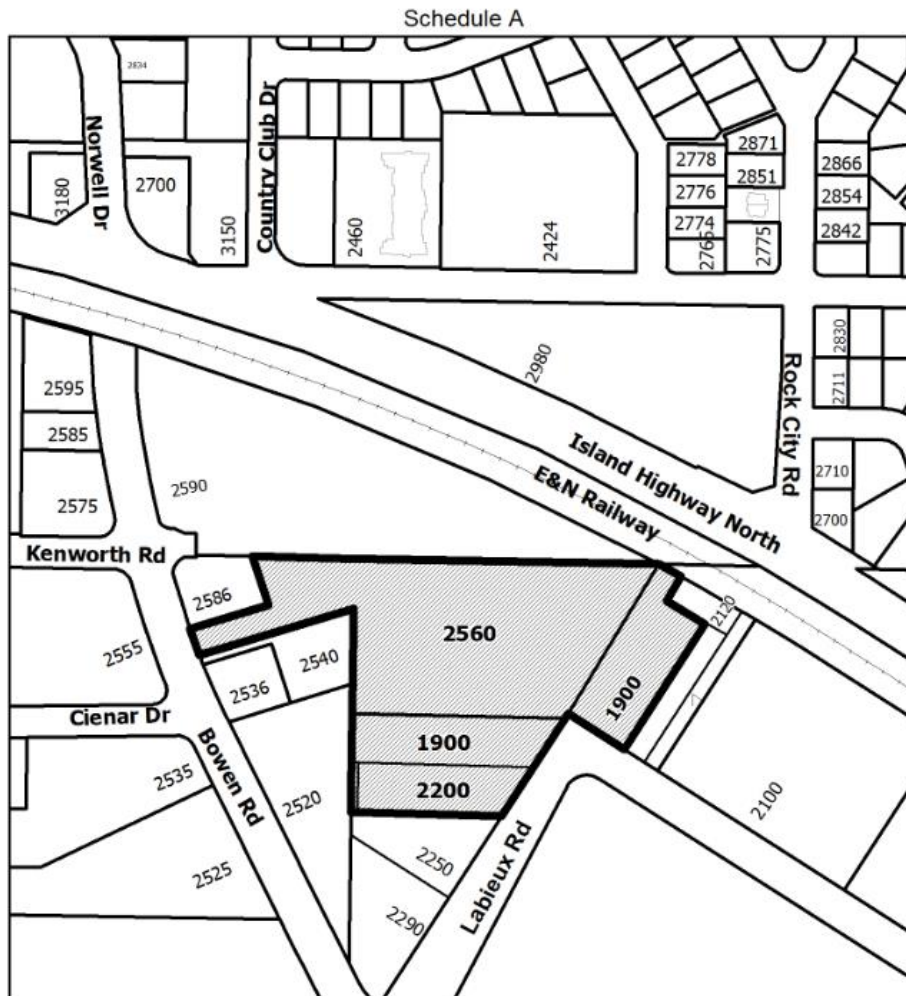

1. Map 1 (Future Land Use Plan) of the "OFFICIAL COMMUNITY PLAN BYLAW 2008 NO. 6500" is amended as follows:

- a) Redesignate the subject area known as LOT A, SECTIONS 18, 19 AND 20, RANGE 7, MOUNTAIN DISTRICT, PLAN 2299, EXCEPT IN THOSE PARTS IN PLAN 16078, 27441 VIP58294 AND VIP62569 (2200 and 1900 Labieux Road), and LOT B, SECTION 20, RANGES 6 AND 7, MOUNTAIN DISTRICT, PLAN 43870 (2560 Bowen Road) from Light Industrial to Corridor.
