



### Old wood-burning appliances eligible for the rebate include:

- Free-standing, non-EPA certified stoves, homemade or barrel stoves (usually installed prior to 1994);
- Airtight, non-EPA certified fireplace inserts or tube-type heat exchangers with face plate and door (like the Free Heat Machine or Welenco) that are currently installed in an open-hearth fireplace;
- Non-EPA certified wood furnaces (ducted, forced air, home heating appliances). Note, they may only be replaced by an EPA-certified wood furnace or gas fireplace; and
- Wood burning cook stoves.

### Appliances NOT eligible for the rebate include:

- Electric stoves or fireplaces (replacement electric inserts are allowed);
- Factory-built (zero clearance) fireplaces;
- Natural gas or propane-fired appliances
- Outdoor appliances (replacement units must be installed in an area with four walls, a ceiling and a door); and
- Tin heaters/tent stoves.

## REMEMBER...

### DO NOT burn the following materials:

- Wet or green wood
- Driftwood
- Pressure-treated wood
- Plywood
- Painted wood
- Cardboard
- Garbage
- Plastics
- Particle board
- Coal

# How to Receive Your Rebate

## Purchasing Your New Appliance



To qualify, you must have an old woodstove eligible for replacement or removal - usually a stove installed before 1994, or a EPA/CSA certified woodstove you're keeping. Contact any of our participating retailers for advice on a qualifying low-emission heating appliance - [rdn.bc.ca/community-woodsmoke-reduction-program](http://rdn.bc.ca/community-woodsmoke-reduction-program).

Upon purchase of your new appliance, the retailer will give you a rebate voucher. **To collect your rebate, complete the following five steps:**

- 1 Use participating retailer and ensure the retailer completes and signs the voucher.
- 2 Check the voucher to see what other information/documents you need to submit.
- 3 Recycle your uncertified stove at an authorized disposal location (retailer may handle). Exceptions apply.
- 4 Upon disposal, have your voucher signed or request a disposal receipt.
- 5 Submit your rebate voucher and supporting documents to your qualifying location:

## Installation

Make sure your new appliance is installed properly. Your retailer can assist with installation, or you can consult a certified professional under the Wood Energy Technical Training (WETT) program.



## Disposal Locations

Your retailer will usually dispose of your old appliance for you. Woodstoves must be properly disabled for recycling at one of the following regional facilities:

## Receiving Your Rebate

Submit the required documents to our website: [www.rdn.bc.ca/rdn-rebate](http://www.rdn.bc.ca/rdn-rebate) (this can be done by email). Following submission, you will receive a rebate cheque:

Woodstove to electric insert	<b>\$400 rebate</b>
Woodstove to woodstove	<b>\$600 rebate</b>
Woodstove to pellet stove	<b>\$1,000 rebate</b>
Woodstove to heat pump	<b>\$1,500 rebate</b>

## Important Program Changes

- 1) Electoral Area Residents that install a new heat pump have the option to keep your existing certified woodstove. **Conditions apply.**
- 2) All applicants must complete a mandatory online survey as part of the application.

## Burn it Smart! Principles

Simple steps can reduce your firewood needs by one third and reduce smoke pollution by 70 per cent.

- Look for the professionals** – Have your system inspected annually and cleaned as often as required
- Use properly seasoned wood, stored to keep it dry**
- Never let your fire smolder**
- Never burn anything other than firewood and a small amount of newspaper**

**Remember - where there's smoke there's pollution: with these steps you can protect your community.**
