The mandate of the Advisory Committee on Accessibility and Inclusiveness is to promote social and political equity within existing and proposed City plans, policies, bylaws and infrastructure and make recommendations to ensure that they are inclusive and accommodating to citizens of all ages, abilities and walks of life.

- Identify best practices in other communities and make recommendations based on the findings to promote social and political equity;

- Participate in reviewing City of Nanaimo draft plans, policies and procedures to prevent the creation of barriers in the future;
- Assist in developing a strategy for engaging with the community on issues relating to accessibility and inclusiveness;
- Discuss other issues referred to the Committee by Council, the CAO, GM's or Directors; and,
- Work with Council to increase public awareness on issues related to accessibility and inclusion for all citizens.

## Section 3 - Membership

One of the challenges in creating a committee of this nature is ensuring that representation is balanced. For a committee to function well, we recommended that the membership does not exceed 13 members – this is to ensure that every voice around the table has the opportunity to be heard. Finally, by identifying groups that represent a very specific demographic in membership, it by nature excludes other groups. With this in mind, the draft Terms of Reference was created to include members nominated by organizations that represent a broad range of individuals affected by issues related to accessibility and inclusiveness.

The proposed membership is as follows:

- a. Two members of Council
- b. Nine members who are appointed from various agencies. The members must include:
  - i. one member nominated by the Child Development Centre
  - ii. one member nominated by Island Health, representing those working with persons with disabilities in the City of Nanaimo
  - iii. one member nominated by the Multicultural Society
