## Review process for City's 2020 budget begins next week

eTown Hall and other opportunities for public review, input available

## **Summary**

Preparations are underway for the City of Nanaimo's 2020-2024 Draft Financial Plan. Residents will have a number of opportunities to review, ask questions and provide input leading up to a budget-focused eTown Hall on Monday, December 2.

Council will begin reviewing draft budgets and project plans over the course of four Special Finance and Audit Committee meetings on November 20, 22 and 25 and December 2. All meetings are open to the public and will be held in the Vancouver Island Conference Centre's Shaw Auditorium.

The eTown Hall will start at 7 p.m. during the Council Meeting and will run for one hour. If necessary, an additional 30 minutes will be allocated. Residents are encouraged to review available information prior to the start of the meeting.

- As this is only a draft version, budgets and plans may change as work progresses in review process.

- To date, the City of Nanaimo has held 10 eTown Hall meetings. The first eTown Hall meeting, held in March
  of 2013, was awarded Bronze for Innovation Management by the Institute of Public Administration of Canada
  (IPAC).
- In accordance with the Community Charter, municipalities must prepare a five-year financial plan each year. Municipal Councils must adopt each annual five-year financial plan before adopting of a property tax bylaw by May 15.
