Financial Relief: Options to defer your taxes

Did you know? If you are eligible, you can defer your property taxes. This provincial program provides low-interest loans to qualified homeowners to pay their property taxes.

Do I qualify for tax deferment?

Two options are available:

- Regular program: you are 55 or older, widowed or a person with disabilities.
- Families with Children program: you are a parent, stepparent or financially supporting a child.

In order to defer, any overdue property taxes from previous years, outstanding penalties and interest charges must be paid and you must have enough equity in your home - 25% for the Regular program and 15% for the Families with Children program.

How does it work?

If your application is approved, the Province of BC will pay your 2020 property taxes on your behalf. Interest is charged on tax deferment loans - 1.95% for the Regular program and 3.95% for the Families with Children program.

Deferred taxes and interest are paid when your home is sold or transferred. Deferment is only available on primary residences; cottages and rental properties do not qualify.

How do I apply?

To apply you will need your annual property tax notice, Social Insurance Number, date of birth and any supporting documentation if necessary.

NEW FOR 2020: The Province has created an online system for processing new deferment applications and renewals. This means the City no longer accepts deferment applications.

As a community, we must come together to work our way through this to keep Nanaimo a great place to live, work and play. We understand many of you are facing financial uncertainty due to the COVID-19 pandemic and, as of print date, Council is working on ways to ease some financial pressures such as extending the deadline for property tax late payment penalties to October 1, 2020 for all property classes.

We want to thank those who pay their property taxes by July 2, 2020. These payments make sure the City has cash flow to pay the businesses we rely on for supplies and important infrastructure projects, to make payroll and to pay the taxes we collect for other governments such as the Regional District of Nanaimo (RDN).

You have the option to pay as much as you can before the 2020 penalty date. The late charge is only calculated on the amount you owe, not the whole bill. Before July 2, 2020, make sure to claim your Home Owner Grant to reduce your overall tax bill.

You also have longer to pay any City of Nanaimo user rate bills. The due date for water, sewer and garbage bills issued after March 17, 2020 has been extended from 30 days to 90 days. The 5% early payment discount has been extended to 90 days.

Save on Taxes: Claim your Home Owner Grant

The Home Owner Grant is a great way to reduce the amount of your property tax bill. Eligible homeowners under the age of 65 can reduce their taxes by up to \$770 and up to \$1,045 for seniors or persons of disabilities. You must claim your grant every year.

You can claim an extension for the prior year from the provincial government if you meet certain qualifications. However, until you claim your grant, your tax bill will remain outstanding. Retroactive grant application forms are valid for the preceding year only and are available from the Property Tax department. Evidence for proof of residency is required. Claim your grant at www.nanaimo.ca/goto/HOG.

DID YOU KNOW?

The City of Nanaimo owns over \$3 billion in assets. Among these are parks, buildings such as City Hall and recreation centres and City roads, bridges and the network of pipes that bring you fresh water and take away your wastewater.

Your Tax Bill: How your taxes are assessed

The City of Nanaimo determines the tax rate based on what we need to balance the budget for the year. Your tax bill is calculated based on your property's assessed value, which is determined by BC Assessment each year, and then by the tax rate plus the parcel tax for the Regional District of Nanaimo (RDN).

Your Property \$1,000

Assessment x Tax Rate = Your Portion of Property Taxes

Just because you received an increase in your assessment does not necessarily mean there will be a significant increase in your property taxes. The important factor is how your assessed value changed relative to the average change for your property class. For example, the assessment for a typical single family residential home in Nanaimo increased by 1.69% this year:



If your assessment is in line with the average (1.69%), your City of Nanaimo property tax notice will equal any tax increase for this year.



If your assessment is higher than average, your property tax increase will be higher than the tax increase for this year.



If your assessment is lower than average, your property tax increase will be lower or you may not have one.

The City also collects taxes for the agencies listed below that offer services in the city. They determine a tax rate needed for their operations in a similar fashion:

- Nanaimo-Ladysmith School District
- **BC** Assessment
- Municipal Finance Authority
- Regional District of Nanaimo (RDN)
- Vancouver Island Regional Library
- · Parcel tax for RDN

City Budget: How your tax dollars are used

The taxes you pay to the City of Nanaimo go toward municipal services, projects and programs such as clean drinking water, paved roads, recreation centres, parks, police and fire services. Also, one per cent goes towards an increase in funding for the general asset management reserve.
