# Park dedication removal for 502 Howard Ave to go to Alternative Approval Process

Removal of old Harewood School field to facilitate the Te'tuxwtun project

### **Summary**

The City of Nanaimo will commence an Alternative Approval Process (AAP) to gain permission from residents to remove park dedication from the old Harewood School field located at 502 Howard Avenue. The process begins Wednesday, Sept. 6, 2023, and will run until Tuesday, Oct. 10, 2023.

The Park Dedication Bylaw Amendment Bylaw 2023 No. 7182.01, which received three readings from Council on Aug. 28, 2023, will remove the park land designation on 502 Howard Avenue. This AAP is running concurrently with City Plan Amendment Application No. OCP103 and Rezoning Application No. RA493 as part of the Te'tuxwtun Project.

The Te'tuxwtun Project is a joint initiative between Snuneymuxw First Nation, the City of Nanaimo, BC Housing and Nanaimo Ladysmith Public Schools to redevelop the properties at 564 Fifth Street, 502 and 505 Howard Avenue.

## **Key Points**

- The Alternative Approval Process will run from Wednesday, Sept. 6 until Tuesday, Oct. 10 at 4:30 p.m.
- Residents who DO NOT support the removal of the park dedication at 502 Howard Avenue may fill out an Elector Response Form which will be made available on Wednesday, Sept. 6.
- If 10 per cent or more of eligible voters submit an Alternative Approval Process form in opposition, the park dedication removal bylaw will be brought back to Council to determine if Council would like to proceed with the matter and next steps.
