BYLAW NO. 2255  
A BYLAW TO DEDICATE LAND FOR PARK PURPOSES

---

The Council of the City of Nanaimo, in open meeting assembled, hereby ENACTS AS FOLLOWS:

1. Title

This Bylaw may be cited as "PARKS DEDICATION BYLAW 1980 NO. 2255".

2. The lands described in Schedule "A" attached hereto and forming part of this Bylaw, are hereby dedicated as public parks and shall be named as set out in said Schedule "A".
3. The question of such dedication shall be submitted to the electors of the City of Nanaimo on 1980-NOV-15 between the hours of 8:00 a.m. and 8:00 p.m. An advance poll shall be held at the Nanaimo and District Savings Credit Union Hall, 250 Albert Street, Nanaimo, B.C., on 1980-NOV-06 between the hours of 8:00 a.m. and 8:00 p.m.
4. The question on the ballot shall be as follows:  
  
"Are you in favour of the described lands being dedicated as public parks?"  
  
And the ballot shall be in such form as to enable the elector to indicate his assent or dissent by making the prescribed mark opposite the word "Yes" or "No" with respect to each park to be dedicated.
5. A ballot shall not be rejected only for the reason that the ballot has not been marked in respect to each park identified thereon.
6. The Council is hereby authorized to establish, by resolution, the polling stations to be used for the taking of the vote.
7. Mr. Sandy T. Gray, Deputy City Clerk, is hereby appointed Returning Officer for the taking of the vote with the power to appoint such Deputy Returning Officers as may be necessary, and the vote shall be conducted as nearly as may be in conformity with the provisions of the *Municipal Act* relating to elections.
