BYLAW NO. 7447

A BYLAW TO IMPOSE A PARCEL TAX ON BENEFITING PARCELS FOR THE FINANCING
OF THE HOME ENERGY RETROFIT PROGRAM

WHEREAS Divisions 4 and 5 of Part 7 of the *Community Charter* authorizes the Council of the City of Nanaimo to impose a parcel tax within a local area service for the purpose of recovering the financing costs of a local area service;

AND WHEREAS the Council deems it desirable to impose a parcel tax for the purpose of recovering the financing costs of the Property Assessed Clean Energy (“PACE”) program (the “Program”) authorized by the petition of the owners of the land in the local area service, as per the Home Energy Retrofit Financing Local Area Service Establishment Bylaws referenced in Schedule A;

AND WHEREAS responsibility for payment of the financing amount as reflected in Schedule B is to be allocated to the owners of all parcels within each service area, as established by the Local Area Service Bylaws (the “Service Area”);

THEREFORE BE IT RESOLVED that the Council of the City of Nanaimo in open meeting assembled, hereby ENACT AS FOLLOWS:

1. Title

This Bylaw may be cited for all purposes as “2026 Home Energy Retrofit Parcel Tax Bylaw 2026, No. 7447”.

2. Service Area

A parcel tax shall be imposed on all parcels within the Service Area established by the Local Area Service Bylaws in Schedule ‘A’ and the Parcel Tax Roll prepared pursuant to Section 6 shall be used to impose the tax.

3. Purpose of the Tax

The parcel tax imposed under Section 1 of this Bylaw is for the purpose of recovering the costs of the program authorized by the Local Area Service Bylaws referenced in Schedule ‘A’.

4. Term

Subject to Section 9, the parcel tax imposed under this Bylaw will be imposed for a ten (10) year term.

5. Parcel Tax Roll

The Collector shall prepare the parcel tax roll for the purpose of imposing the parcel tax.

6. Parcel Tax Basis

The parcel tax imposed under Section 3 of this bylaw shall be on the basis of a single amount for each parcel within each Local Area Service as reflected in Schedule 'A'.

7. Parcel Tax Amount

The amount for each parcel is reflected in Schedule 'A'.

8. Reduction of Parcel Tax Amount

The parcel tax imposed in this Bylaw shall be waived in its entirety where the owner of a parcel subject to the parcel tax has paid a single payment in cash to the Collector of the amounts set out for the parcel in Schedule 'B' on or before the date set out for that parcel in the corresponding 'Due Date' column of Schedule 'B'.

9. Severability

If any section, subsection, sentence, clause, or phare of this Bylaw is for any reason held to be invalid by the decision of any court or competent jurisdiction, such decision shall not affect the validity of the remaining portions of the Bylaw.
