2026 PROVISIONAL BUDGET QUICK FACTS



The 2026-2030 Provisional Financial Plan (provisional budget) has passed three readings and will go for adoption by Council in January 2026. The provisional budget outlines strategic investment in services and infrastructure to support a growing community of over 100,000 residents and the stewardship of more than \$4.8 billion in assets (as of 2021). Departmental business plans and project initiatives are aligned with the City's Integrated Action Plan, reinforcing the City's commitment to achieving the five key goals identified in City Plan: Nanaimo Relmagined

HOW WILL THE 2026 BUDGET AFFECT ME?

Total projected revenues for 2026 are \$288.1 million with 62.5% coming from property taxes and 24.9% from user fees and charges. The amount of municipal taxes you pay depends on your property type and your property's assessed value.


The City's budget includes a 6.3% increase in taxes on the average home in the City, which includes 1.0% for asset management.


