

Building Inspections

WORKSAFE REQUIREMENTS FOR DEMOLITION PERMITS

WorkSafeBC requires a qualified person inspect the building to identify any hazardous materials that may be on site and that these materials are properly removed and disposed of by trained and qualified professionals before demolition begins and after a Notice of Project has been submitted to WorkSafeBC. Buildings constructed prior to 1990 are of particular concern for asbestos-containing materials (ACM) and must be dealt with accordingly.

Archaeological sites may also have an impact on demolition permit applications.

Please note that the completed **Hazard Assessment Report** is required prior to Building Permit issuance.
