1.0 GENERAL INFORMATION

1.1. PURPOSE: To provide a written, formal policy for employment and/or sponsorship of all candidates attending Academy courses to meet the Province of British Columbia Ministry of Advanced Education Private Training Act Policy & Legislation. In addition to clearly state expectation of student conduct.

1.2. **RESPONSIBILITY:** It is the responsibility of the Academy to be familiar with this guideline to ensure that all candidates meet the employment and/or sponsorship criteria before being enrolled in Academy courses. It is the responsibility of the Academy to ensure students are made aware of student conduct expectations.

2.0 PROCEDURES

- 2.1 It is the policy of the Academy that candidates must be employed by, or be a member of, one of the following:
 - 2.1.1 Career or Volunteer Fire Department
 - 2.1.2. Emergency Paramedic Service
 - 2.1.3 Law Enforcement
 - 2.1.4. Military
 - 2.1.5. Industrial Fire Brigade
 - 2.1.6. Land or Water Search and Rescue
 - 2.1.7 Any other Emergency Response Organization deemed acceptable by the Fire Chief
- 2.2 It is the policy of the Academy that all candidates are sponsored and authorized by their Employer or Volunteer organization to attend courses.
- 2.3 All correspondence regarding the candidate will be with the candidate's employer or sponsor.

3.0 STUDENT CONDUCT

- 3.1 Students will adhere to all Academy safety rules and regulations.
- 3.2 Horseplay will not be tolerated.
