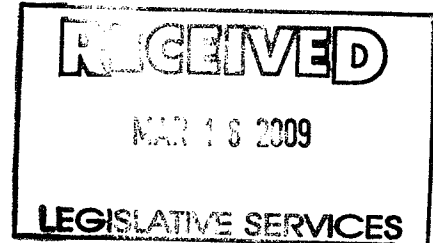

I have attached the Campaign Organizer Campaign Financing Disclosure Statement for the 2008 General Election as required in the Local Government Act. I do want to note the four (4) following issues:

1. That it is the requirement of the candidates to report any donations that they received from our union and not CUPE BC's. As such they are not included in this report.
2. That the amount \$69,198.01 identified in the report as the summary of election expenses is the total amount spent on our campaign across the province. This is allowed for under the Act and referred to on page 30, where it states "*The Financial Agent may produce a single report for the overall election campaign, including activities in each of the jurisdictions where candidates were endorsed.*"
3. CUPE BC did not solicit or receive any Campaign Contributions so this part of the Report is blank.
4. The attached list of endorsed candidates may not include candidates from your area. However in those cases, we did encourage our members to get involved in the elections and they would have received a letter from our Union to that effect. That would have resulted in us exceeding the \$500.00 plateau.
