Nanaimo's Voice at UBCM Gets Stronger

Summary

Last week, members of Nanaimo's City Council attended the 2019 Union of BC Municipalities (UBCM) Convention, held in Vancouver. The UBCM Convention is an annual event that provides local governments, from across the province, the opportunity to gather, share their experiences, and take a united position on issues impacting their communities. Through panel discussions, meetings with provincial ministers, and endorsement of Resolutions; creation of new policies, both at the local and provincial levels of government, can occur to strengthen local governments.

During the 116th UBCM Convention, Nanaimo City Council brought forward Resolutions, were panelists speaking about the environment and social issues, and so much more:

Nanaimo Council's UBCM Resolutions Focus on Enhancing Strategic Themes: Environmental Responsibility, Governance Excellence, and Economic Health

- Governance Excellence:
 - (Endorsed) Resolution B124, Property Taxation: Amendment to Section 193 of the *Community Charter* to allow municipalities to adjust their property tax rates by setting density brackets in their jurisdiction, to use at their discretion, as an incentive to reduce urban sprawl and as a method of assigning infrastructure and maintenance costs more accurately amongst end users.
 - Resolution C19, Development Cost Charges: the provincial government amend the Local Government Act to allow for the imposition of Development Cost Charges in areas other than sewage, water, drainage, highway facilities and park land.

- Environmental Responsibility:
 - Resolution B157, Indoor Agricultural Fertilization Practices: the provincial government to explore including in the BC Agricultural Best Practices, the requirement for closed loop greenhouse irrigation systems in commercial greenhouse and indoor agricultural structures, to prevent commercial fertilizers from being emitted into the environment.
 - Resolution B169, Low Impact Foundation Systems for Farm Use Structures: the provincial government to encourage the use of low carbon, low impact, cementfree foundation technologies for farm use structures and buildings within the ALR, thereby reducing the deposition of fill material and elimination of arable soil capability in the long term.
- Economic Health:
 - (Endorsed) Resolution B167, Cannabis Plants on the Agricultural Land Reserve: please note there were a number of requests for consideration, including that the provincial government amend the ALR Regulation in order to clarify the interpretation of section 2(2.5) of the ALR Regulation regarding the lawful production of cannabis "inside a structure (a) that has a base consisting entirely of soil", and clarify that when producing cannabis in a greenhouse, it has the same meaning as "Greenhouse" under section 2(o)(i) of the Regulation. Circumscribing cannabis production in structures that are lawful by regulation for all other crops, may not withstand judicial review.

Please note that due to time constraints, resolutions <u>B169 to B193.1 in Section B – Part 3-b</u>, were referred to the UBCM Executive.

Government Advocacy

City of Nanaimo Council also met with provincial ministers and senior government staff to discuss mental health and addictions as well as transportation related-matters impacting the City:

- Monday, September 23, 2019: met with the President and CEO of Island Health, Kathy MacNeil as well as the Board Chair, Leah Hollins.
- Tuesday, September 24, 2019: met with the Honourable Judy Darcy, Minister of Mental Health and Addictions.
- Thursday, September 26, 2019: met with the Honourable Claire Trevena, Minister of Transportation and infrastructure.

Mayor Krog was also interviewed by a number of media outlets such as <u>CBC News</u> and the <u>Vancouver Sun</u> on compassion fatigue as it relates to homelessness and mental health.

Nanaimo Takes Seat at the UBCM Executive Table

Congratulations to Councillor Ben Geselbracht who was elected as one of five (5) Directors at Large on the UBCM Executive. The members elect an Executive during the Convention to ensure the directions set by the general membership are carried forward.
