The City of Nanaimo "ZONING BYLAW 2011 NO. 4500" is varied as follows:

1. Section 13.4.1 Siting of Buildings – to reduce the minimum front yard setback from 7.5m to 6.22.

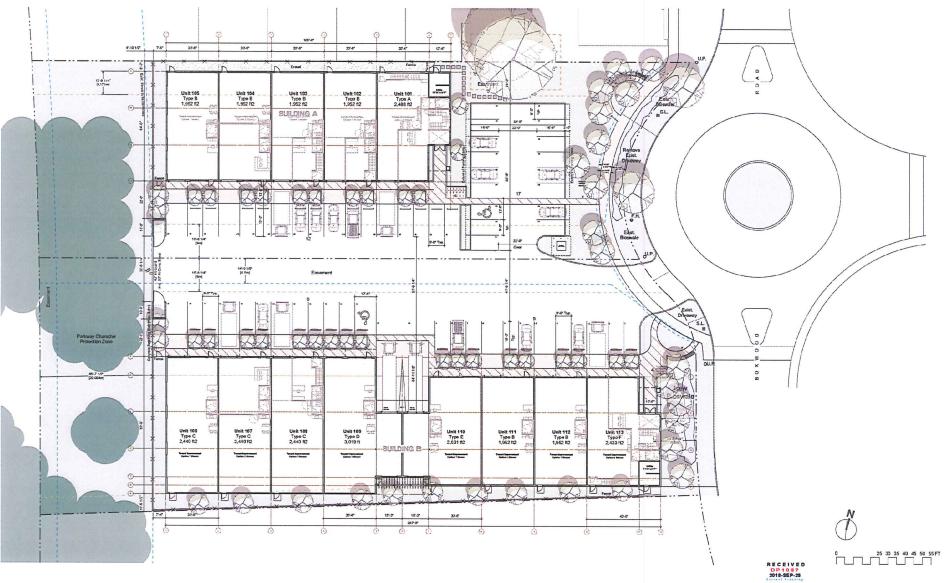

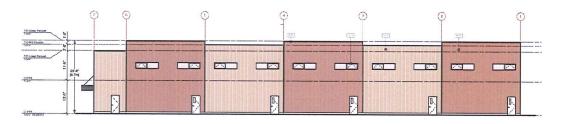

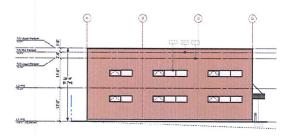
1) Building A - South Elevation Scale: 3/32" # 1'-0"



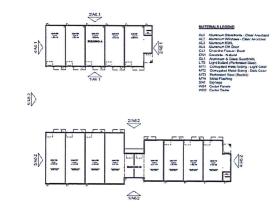
3 Building A - North Elevation Scale: 3/32* = 1'-0"
