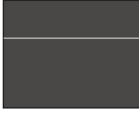
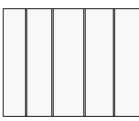
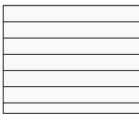
EAST ELEVATION

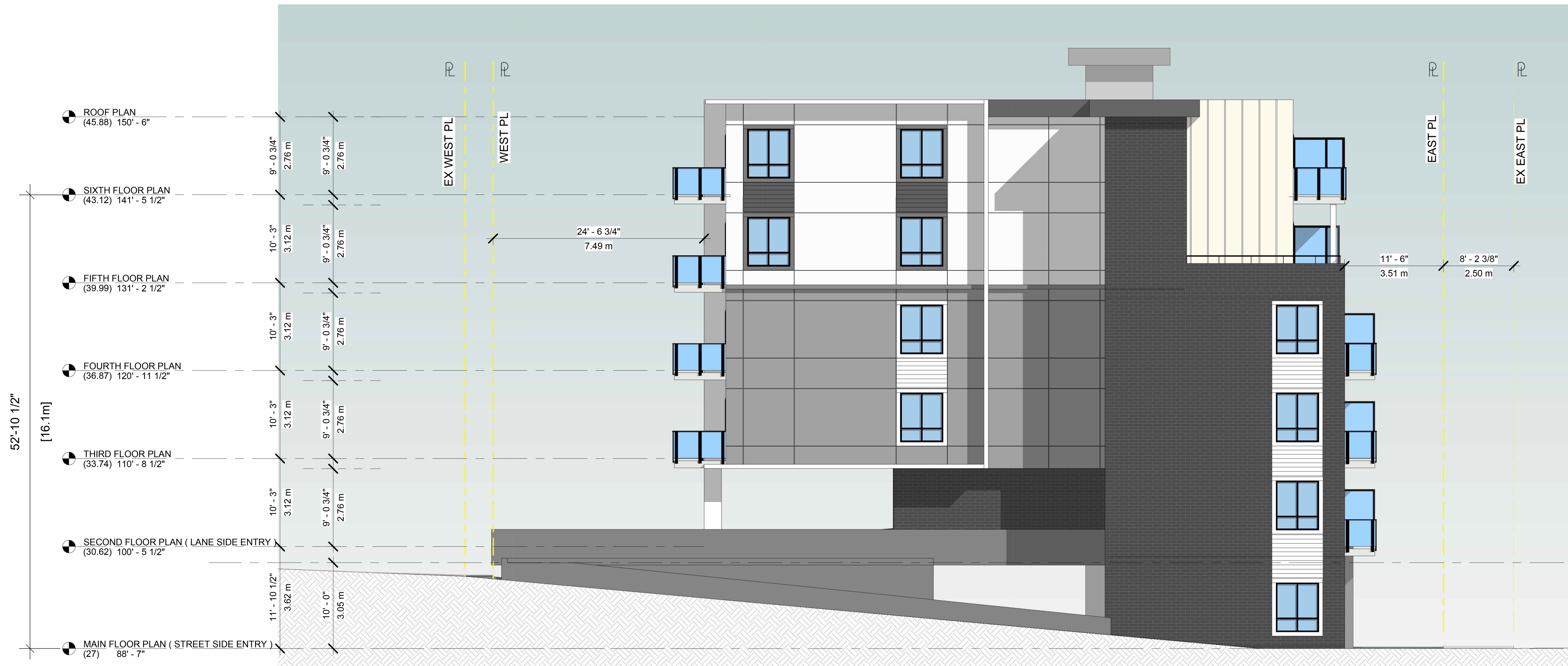
